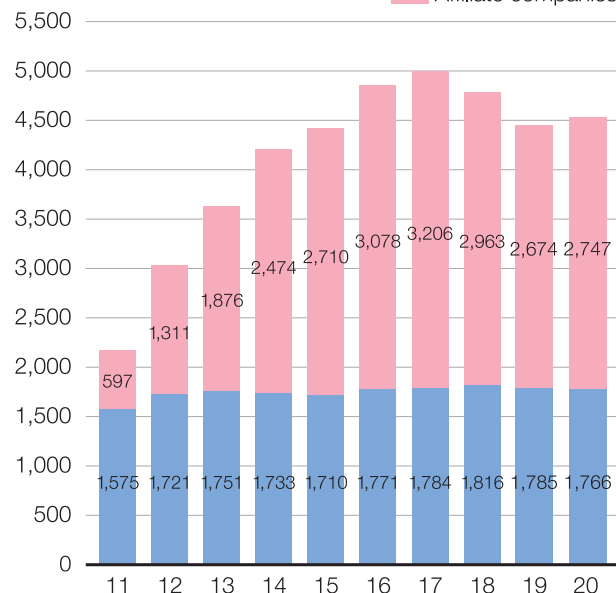
History

1971 November	HAMANAKODENSO was designated a QC model plant by Nippondenso Co., Ltd.
1979 November	Awarded the DEMING PRIZE.
